1.5.1 Most Favored Customer

To provide ongoing competitive prices to users of this contract, the contractor shall ensure that the State shall receive favorable rates in each LATA during the term of this contract. The rates set forth shall not exceed the contractor's commercial price list, its established tariff, or rates being provided to its largest service customers rates being provided to large similarly sized retail service customers. Similarly sized retail service customer will be defined as any retail customer whose average monthly usage minutes over a 12 month period is less than or equal to the average of the State's six highest months of usage minutes in that same 12 month period. If at any time this should occur, the contractor shall immediately notify the contracting office and offer the lower prices for incorporation into this contract.

Within a month after the end of each contract year, the Contractor will notify the contracting office and confirm that the State's rates that do not exceed the contractor's commercial price list, its established tariff, or rates being provided to its other large similarly sized retail service customers.
