This Contract Modification #5 ("Modification") to the above-referenced contract ("Contract") is made by and among the State of Maryland, acting through its Department of Information Technology ("State"), and Verizon Maryland LLC ("Contractor").

RECITALS

WHEREAS, on May 8, 2019, the State exercised the first one-year renewal option through June 30, 2020, in the amount of \$5,000,000 increasing the Contract not to exceed ("NTE") value to \$30,000,000;

WHEREAS, on June 17, 2020, the State exercised the second one-year renewal option through June 30, 2021, with no increase to the NTE value;

WHEREAS, in Modification No. 1, the Contract was modified increasing the NTE value by \$7,021,191.73 to \$37,021,191.73;

WHEREAS, in Modification No. 2, the contract was modified to extend the term through March 31, 2023 and increase the NTE by \$3,000,000 to \$40,021,191.73;

WHEREAS, in Modification No. 3 the contract was modified to extend the term through June 30, 2023;

WHEREAS, in Modification No. 4 the contract was modified to extend the term through January 31, 2024 agreeing to a 15% price increase and increase the NTE by \$4,500,00.00 to \$44,521,191.73.

WHEREAS, the State and Contractor desire to extend the Contract term through July 31, 2024, agreeing to the updated price form attached hereto as Attachment A, with no increase to the NTE value.

NOW THEREFORE, in consideration of the Recitals above, which are made a substantive part hereof, and the promises and covenants herein contained, the adequacy and sufficiency of which are duly acknowledged, the Parties agree as follows:

1. Section 3. Time for Performance: The Contract is modified to extend the period of performance through July 31, 2024.

2. Section 4. Consideration and Payment: The Contract is modified by the addition of the updated price form at Attachment A hereto and which is incorporated by reference herein.
