Yes, Prime Master Contractors may use the experience of their Key Personnel to meet Company Minimum Qualifications if: 1) the Key Personnel are employees of the Prime; and 2) the Key Personnel obtained the experience through work performed under a contract awarded to the Prime Master Contractor.

The Portal delivered as a result of Work Order #1 will simply direct users to the appropriate existing link/methodology.

The State utilizes multiple work order and/or incident management systems across Agencies, Departments, and projects.
