Answer 2:

- A. "Documentation" refers to all required documents, ie: Attachment 5 Labor Category Personnel Resume Summary, Certifications, etc. Any information requested or not, that shows the Company and the Resource meet the Minimum Labor Category Qualification, Personnel minimum qualifications and personnel other requirements.
- B. The State is expecting that an Attachment 5 Labor Category Personnel Resume Summary be provided for each candidate (resource), as well as required certifications, and all other additional information demonstrating that all Minimum Qualifications requested are met.
- C. An Attachment 5 Labor Category Personnel Resume Summary is required, and should be used to show each candidate has met the Labor Category minimum qualifications, personnel minimum qualifications, personnel other requirement and any additional information requested or not that show the resource has met or exceed the minimum qualifications.

Question 3: Reference: Section 3.2.1.B

Question: Please confirm that the State is not looking for resumes, and that Attachment 5 will "replace" the need for a resume.

Answer 3:

Resumes are not requested in the TORFP. Attachment 5 – Labor Category Personnel Resume Summary's are requested only. All information that demonstrates the resource meets all the Labor Category minimum qualifications, personnel minimum qualifications, personnel other requirement and any additional information requested or not that show the resource has met or exceed the minimum qualifications should be included in the Attachment 5

Please confirm that the State is expecting that these work assignments are those of the proposed personnel, rather than the offeror.

Answer 5: Reference Section 2.5.3.4

Personnel should have the minimum tools to be able to Install, Terminate and Certify Cat6 and Fiber Optic cabling.

In addition to standard work tools (such as various style pliers, flat and Phillips head screwdrivers, std hammer, rubber mallet, box & sheet metal cutters, drill & bits, measuring tape, stud finder), Minimum Cable Tools required should include but not limited to (some examples):

Cable Cutting and Stripping Tools

Crimping Tools

Cable Tester for testing continuity, wiring faults and cable connections

Cable Tone Generator and Probe

Cable Punch Tools

Fiber Continuity and Loopback Tester

Minimum 50' Fish Tape

Any special tools will be supplied by MDOT and personnel should be experienced in using the following (some examples) or equivalent tools:

FLUKE DTX1800 Cable Analyzer and OTDR EXFO FTB-1 and OTDR Sumitomo DCM Fusion Splicer Cable Rodder

All cables (CAT6 / Fiber), patch panels and connectors will be supplied by MDOT.

Will the government provide the cost for travel to various sites or the hourly cost has to account for all travel and tools?

Please reference Note in 2.5.3:

Offerers shall factor transportation (to include vehicle van or truck, gasoline and all fluids, adhere to applicable recommended manufacturer vehicle maintenance services) for the Network Cabling Support resources into their proposals. Vehicle will need to be able to transport Network Equipment such as 4-post racks, network switches, routers and UPS units.
