So with that out of the way, I'm going to ask you two ladies just to introduce yourselves for the record and then I will turn it over to Greg Talley.

This is a recompete and the incumbent, I believe... Yes, this is a recompete. The vendor is Advanced Systems Software. Okay. Well there are just the two of you, just go back and forth. Candace said she didn't have any questions.

MS. CARPENTER:

MS. GUDUDURI:
