THIS CONTRACT MODIFICATION (the "Modification") is made this 18th day of APRIL 2012, by and between the State of Maryland (the "State"), acting through the Department of Information Technology ("the Department") and Verizon Select Services Inc. ("VSSI") to Contract No.060B1400006 (the "Contract") for long distance communications services, teleconferencing services, and calling card services (the "Services") for the State of Maryland.

WHEREAS, on or about August 25, 2005, the State, acting through the Department of Budget and Management, and VSSI entered into the above-referenced Contract whereby VSSI was to provide long distance communications, teleconferencing services, and calling card services for the State of Maryland as set forth in the Contract; and

WHEREAS, the Department of Information Technology was established on July 1, 2008 and is now responsible for all Information Technology matters previously under the control of the Department of Budget and Management; and

WHEREAS, on July 28, 2010, the Board of Public Works approved an extension of the original Contract through August 31, 2011, so that the Department could issue a new solicitation for these services; and;

WHEREAS, on August 1, 2011, the Board of Public Works approved an extension of the original Contract through May 31, 2012, so that the Department could complete the new procurement and transition to the new long distance contract with AT&T; and;

WHEREAS, the State, acting through the Department, and VSSI desire to extend the Contract to September 30, 2012, so that the Services will continue to be performed under the terms of the original Contract and the Department can complete a successful transition between Contractors for these Services.

NOW THEREFORE, in consideration of the above facts, the adequacy and sufficiency of which are duly acknowledged by the parties, the following Contract terms and conditions are modified and the parties agree as follows:

- a. The Contract is extended until September 30, 2012
- b. The Recitals set forth above are incorporated herein.
- c. Except as expressly modified herein, all of the provisions of the original Contract, Contract Modification No. 1 and Contract Modification No. 2 remain in full force and effect and are hereby ratified and confirmed.
