- Mark Cather begins a discussion on centralization
- Ken Kurz views centralization and procurement as "hand-in-hand."
- Senator Hester suggests focusing on specific portions of the commission's goals, which previously had a bigger-picture approach.
- Manoj Srivastava suggests dividing the commission into smaller action groups.
- More meetings will be needed; Patrick Mulford suggests monthly meetings
- The consensus is that smaller groups will get together

Next Steps and Action Items:

1. Formation of Action Groups

- a. Establish smaller action groups to tackle specific goals and initiatives.
- b. Each group is to have a designated leader responsible for reporting progress.

2. Monthly Meetings

- a. Transition from quarterly to monthly meetings to ensure progress.
- b. Schedule the next meeting for August 2024.

3. Role Assignments

- a. The governor's appointment office may expedite the process of filling the remaining three roles on the commission
- b. Each member is to review current roles and propose any necessary adjustments by the next meeting

4. Focus Areas for the Subgroups :

- a. Detailed discussion on procurement processes and potential improvements.
- b. Initial proposals for centralization

c. Updates on security measures and rapid procurement strategies
