#### Primary to Interop User Change:

#### **CSX Railroad Police**

CSX railroad police was previously approved by the Radio Control Board as a Primary User in December 2017. They no longer need their own talkgroups and have chosen to proceed as an Interop User. They are in the process of getting the required signatures on the MD FiRST Interop MOU.

#### Proposed New Interop User:

#### Preston County, WV

The County of Preston, WV formally requested to become an Interop User. Representing Preston County, WV is Justin Wolfe, Assistant Director Preston County OEM/911. Preston County has approximately 5 TDMA radios they plan to use for daily operations when they enter Garrett County for Interoperable communication, primarily with law enforcement as well as Fire/EMS. Currently Garrett County has Interoperability when they enter Preston County WV, Preston County would like to be reciprocal. They intend to enter into Talkgroup Sharing Agreements with Garrett County (Fire, EMS and Law).

Proposed Motion: The Radio Control Board approves the application of Preston County, WV to become a Communications Interoperability User to Maryland FiRST and authorizes the Chairman to conclude the appropriate MOU with Preston County, WV.

## **Proposed New Limited Primary User:**

### Internal Revenue Service-Criminal Investigations (IRS-CI)

The Internal Revenue Service-Criminal Investigations (IRS-CI) formally requested to become a Limited Primary User. Representing the IRS-CI is Terry Miller, Special Agent/ Washington Field Office Radio Communications Coordinator. IRS-CI has approximately 350 TDMA radios, they are requesting one talkgroup that would be used on a limited basis when they are in areas that their system doesn't cover. This will not be their primary mode of communication. They intend to enter into a Talkgroup Sharing Agreement with MSP.

Proposed Motion: The Radio Control Board approves the application of IRS-CI to become a Limited Primary User to Maryland FiRST and authorizes the Chairman to conclude the appropriate MOU with IRS-CI.

### **Proposed New Limited Primary User:**

### Frederick County, MD

Frederick County, MD formally requested to become a Limited Primary User. Representing Frederick County is Jack Markey, Director Emergency Management Division. Frederick has approximately 4,000 TDMA radios, they are requesting up to 6 talkgroups. Their intent is to use MD FiRST primarily for interoperability. However, Frederick County will use their talkgroups in areas of the county that do not have coverage with their current county system. In those instances, they would use the talkgroups to provide the needed coverage. Fredericks limited use of talkgroups in these areas of the county does not cause any capacity concerns with the MD FiRST system.

Proposed Motion: The Radio Control Board approves the application of Frederick County to become a Limited Primary User to Maryland FiRST and authorizes the Chairman to conclude the appropriate MOU with Frederick County.
