Review Minutes from 3/16/2022 - Norman Farley

Proposed New Primary User:

MD Alcohol and Tobacco Commission:

Representing the ATC were Charles Van Howeth, Agent in Charge and Jack Hartzell, Agent Supervisor - formerly part of the Comptrollers Field Enforcement the ATC is now a division under the Governor's Office. Currently they have 15 officers, which will increase to 22 on July 1, 2022. They operate in all counites and Baltimore City. The ATC will continue to operate in conjunction with the Comptroller's Office for the time being. An increase in officers could occur with the potential of the cannabis legalization being absorbed by the ATC.

Proposed Motion: The Radio Control Board approves the application of the MD Alcohol and Tobacco Commission to become a Communications Primary User on Maryland FiRST and authorizes the Chairman to conclude the appropriate MOU with the MD Alcohol and Tobacco Commission.

Proposed New Interop User:

MD Judiciary:

Representing MD Judiciary were Jerry Calabresa, Business Continuity Manager, Sean Wolcoff, Chief of Security and Efren Diaz, Security Manager. MD Judiciary is responsible for security at the Court of Appeals building and other assigned areas in the Annapolis complex. They have 19 Special Police Officers with 8 shared TDMA radios. They are Interoperable with Anne Arundel County and Annapolis Police. They also have driving/escorting and conference assignments with some of the judges in different areas of the state. With recent events involving judges and court rooms around the country they have the need to get real time communications with MSP, DGS Capital Police and possibly others on MD FIRST.

Proposed Motion: The Radio Control Board approves the application of MD Judiciary to become a Communications Interoperability User on Maryland FiRST and authorizes the Chairman to conclude the appropriate MOU with MD Judiciary.

Loudoun County, VA:

Representing Loudoun County, Virginia were Battalion Chief Michael Lamb and Captain Tom Gilligan. They have 3,200 TDMA radios in 8 public safety agencies. They are currently members of MWCOG and NCR and have agreements with all the bordering counties. They would like to increase interoperability and communication, especially along the Potomac River waterways and transportation networks that traverse the Potomac River.

Proposed Motion: The Radio Control Board approves the application of Loudoun County, VA to become a Communications Interoperability User on Maryland FiRST and authorizes the Chairman to conclude the appropriate MOU with MD Judiciary.

Fairfax County, VA:

Representing Fairfax County, Virginia was Jeffrey Holmes, Radio/Wireless Interoperability Manager. They have 6,400 TDMA radios and are currently members of MWCOG and NCR. They represent all public safety in Fairfax County, half of Fairfax County shares a border with MD and the MD waterways. They would like to improve interoperable communication with MD DNR on the Potomac River. As well as to improve interoperability along the American Legion and the Woodrow Wilson Bridges. They have future interests in possibly becoming a Primary User with their own talkgroup(s) for helicopters and a back-up for DC.

Proposed Motion: The Radio Control Board approves the application of Fairfax County, VA to become a Communications Interoperability User on Maryland FiRST and authorizes the Chairman to conclude the appropriate MOU with MD Judiciary.

System Users Committee Status Update - Pat King

No old business was raised, however there was follow-on discussion concerning BDA's in schools and other critical buildings.
