**Questions & Answers**

52. Can a Master Contractor's subcontractor identified in the master contract award uses the subcontractors experience to meet the requirement of 3.9.2 in particular to financial and tax institutions of similar size, scope and frequency?

**Respond:** Yes, a sub-contractors experience is acceptable

53. Although this was ask before but I believe it worth asking again. Can you reconsider the wording "to financial and tax institutions" in section 3.9.2. As you know providing consulting, technical services and helpdesk support services to any industry is pretty much the same in terms of technical capabilities, support and solving IT issues with helpdesk support services? By doing so ROW will have access to innovation and broaden the response from small and very capable business who are already a master contractor.

**Respond:** No, ROW will not reconsider the wording.

54. Will you provide a list of those documents/forms required to be submitted that are part of the CATS+ Master Contract, if any? It is very clear what needs to be submitted from the ROW TORFP as regards documents/forms.

**Respond:** The necessary documents were sent on Addendum 5 email dated 4/11/2019.

44. Section 2.1 describes the TORFP as one where an Offeror will provide four key personnel with additional resources to be added via Work Order. The Financial Proposal asks only for labor rates for the labor categories. However, certain parts of the TORFP appear to add requirements that are more commonly found in managed services or hosting contracts that are priced as fixed price contracts rather than time and materials contracts.

- a. Does Section 3.7.5.A. apply only to TO Contractor hardware or software used in connection with the performance of the TO Agreement; ROW owned hardware and software; or both?

Response: Both

- b. Section 3.7.5.B.1 requires the TO Contractor to "Establish separate production, test, and training environments for systems ." Is ROW providing the environments and all tools and licenses necessary for the separate environments to be established? If the TO Contractor is expected to provide anything beyond personnel to complete tasks, the current Financial Proposal template does not allow the TO Contractor to express those costs.

Response:

Yes, Maryland State Register Of Wills is providing the environments and all tools and licenses necessary.

- c. Section 3.7.5.B.4 says "Unless otherwise directed, the TO Contractor is responsible for the encryption of all Sensitive Data." Is ROW providing the tools to encrypt Sensitive Data? If not, there is no place on the Financial Proposal for the TO Contractor to express the cost of the tools or software that may be required.

Response: Yes, Maryland State Register Of Wills will be proving all the tolls to encrypt all Sensitive Data

- d. To better understand Section 3.7.5.B.5, what State data might TO Contractor manage or control?

- e. In Section 3.7.5. B.6., is the TO Contractor expected to monitor user activities for ROW's systems, the TO Contractor's systems, or both? If the TO Contractor is expected to monitor user activities for ROW's systems, will ROW provide the tool(s) to allow such monitoring?

Response: TO Contractor is expected to monitor user activities for ROW's systems and any TO Contractor systems used for the TO Agreement; the necessary tools will be provided.

- f. In reference to Section 3.7.5.B.8, are ROW's system and network environments currently separated by properly configured and updated firewalls?

Response: YES

- g. In reference to Section 3.7.5.B.10, does ROW currently "deny all" and allow access only by exception?

Response: YES

- h. Section 3.7.5.B.12 requires the TO Contractor to perform vulnerability testing. Is ROW providing the tools necessary to conduct the vulnerability testing? If not, there is no place on the Financial Proposal for the TO Contractor to express the cost of the tools.

Response: YES, ROW will provide the necessary tools to conduct the required testing.

- i. Section 3.7.5.B.16 says the TO Contractor will "ensure that anti-virus and anti-malware software is installed and maintained on all systems supporting the services provided under this TO Agreement. " Does this apply to the ROW's systems, the TO Contractor's systems, or both? If it applies to the ROW's systems, is the ROW providing the licenses for the anti-virus and anti-malware software?

Response: Yes, it applies to all systems which are part of the TO Agreement, ROW and TO Contractor.

- k. Section 3.7.5.B.17 requires the TO Contractor to “Conduct regular external vulnerability testing.” Does this apply to the ROW’s systems, the TO Contractor’s systems, or both? If it applies to the ROW’s systems, is the ROW providing the licenses for the anti-virus and anti-malware software?

Response: Yes, all tools will be provided.

- l. Does Section 3.5.1 Redundancy, Data Backup and Disaster Recovery apply to the ROW environment, the TO Contractor’s systems, or both? If it applies to the ROW environment, does the ROW currently have supporting contracts and/or resources in place to allow for the required data backup and disaster recovery and will the supporting contracts and/or resources continue after award of this TORFP?
- m.

Response: Yes, it applies to all systems which are part of the TO Agreement, ROW and TO Contractor. ROW currently have supporting contracts and/or resources in place, which will extend after the award of this TORFP.

45. Section 2.6.2 says “The Offeror shall consider carefully the resources that will be required to meet these SLAs.” This TORFP is for four key personnel with the possibility of additional personnel being added by Work Orders. How can the Offeror commit to SLAs when the ROW controls the number and type of personnel performing on this contract?

Response: ROW will control the number and type of personnel performing on the contract, but it becomes the responsibility of the TO Contractor to ensure that the SLA expectations are being met. For this the TO Contractor must clearly define the service standards they will provide and is obligated to meet.

46. If the ROW intends to require a SLA for System Availability, does it apply only to down time that is due to things within the control of the TO Contractor? For example, the TO Contractor is not providing the hosting environment or the connectivity.

Response: Yes, SLA for System Availability applies only to down time that is due to things within the control of the TO Contractor.

47. If the ROW intends to require SLAs, is the Offeror expected to propose SLA criteria for Security Management and Help Desk Support Services? The TORFP does not defined minimum criteria for those SLAs.

Response: Yes, the Offeror is expected to propose SLA criteria for Security Management and Help Desk Support Services.

48. If ROW intends to require SLAs, is the TO Contractor expected to report on SLAs on a monthly basis? Section 2.6.4 says “The Offeror’s Proposal shall describe how the Offeror will measure and report on each performance category below, on a monthly basis.” Section 2.6.3 says “Weekly status reports will be used to verify and analyze Offeror conformance with the defined SLAs.” Monthly reporting on SLAs is generally accepted.

Response: Maryland State Register Of Wills expects all reporting on a weekly basis.

49. 1. TORFP section 3.9.2 states, experience with two successful contracts providing consulting, technical services and helpdesk support to **Financial and tax institutions** for at least five years is expected.

At the recent Bidders Conference, a question was asked concerning the requirement and the response at that time was, “we would prefer tax or Finance related but would take others”.

However, when the Q&A was released on 4-2-2019 Question 31 asked “can COM remove this requirement and instead allow it for any government or commercial customer?” and the answer was “No”.

Please provide a definitive answer for the following:

Is citing past performance experience with two successful contracts (of at least 5 years) providing consulting, technical services and help desk support of the same size and scope compliant if the experience is for other than financial and tax institutions?

**Response:**

Offerors may provide experience with other government or commercial customers; however, it is the state’s preferences that offerors provide experience in tax or financial institutions and will be ranked accordingly.

50. In the “Responses to Questions and Answers# 1 – 41” document dated April 2, 2019, it is mentioned in Q&A #5 that the Offeror cannot use a partner company’s past performance to meet the requirements listed in Section 3.9.2. We request COM to revise this and allow past performance of a named sub-contractor on the proposal to be submitted. This will be consistent with TORFP Section 5.4.2 F which does allow (emphasis added) “Master Contractor **and Subcontractor** Experience and Capabilities” to be presented. Will COM clarify this?

**Response:**

Question #5, posted on April 2<sup>nd</sup> is being revised to clarify that the offeror can use the partner company past performance to meet the requirements listed in section 3.9.2.

51. In response to the request for COM to provide Microsoft Word version of the Attachment B and the other required Attachments that need to be submitted (Q&A #26), COM provided the Excel version of the “Attachment B”. Can COM *also* provide MS Word versions of attachments that are required to be submitted as specified in Section 7 of the TORFP?

**Response:**
