A list of experience. 2.7.

MR. ALLEN:

MR. ALLEN:

Lesser contractors.

MS. SCHAD:

MS. SCHAD:

The qualification that asks for at least one year of educational data background?

No, more than that.

MR. ACHREYA:

There are three or four. One of them is?

MR. ALLEN:

Five years. Under the other requirements at least five years experience and just what it says.

MR. ACHREYA:

Yeah, but one of them is educational data requirement, had worked on educational --

MR. ALLEN:

Well, they're all five years.

MR. ACHREYA:

Okay. Five years of educational data.

MR. ALLEN:

Whatever it says.

MS. RICHBURG:

What's the question, Ryan?

MR. ALLEN:

The question is, do you, you specifically, you're looking for somebody with educational data experience or any good person but they had worked on other areas, would also be competent.

MR. ALLEN:

They'll be considered but we're looking for education but it could be, like it says, the local, state or federal agency, better education agency.

MR. BLACKBURN:

Okay. Ms. McGlenn?

MS. McGLENN:

No questions.

MR. BLACKBURN:

Okay. The questions are completed? All right, Dorothy.

MS. RICHBURG:

Come on now. I know we have a couple of other questions. Okay. Thank you. Marc did a very good job on that one.

VOICE:
