**Requesting Agency Remarks:** The Geographic Information Systems Software Master Contract is intended to obtain software by providing Master Contractors the opportunity to propose Purchase Order Requests for Proposals (PORFP) for specific services.

The vendors have provided the required software through the course of the contract for several agencies. Pricing is determined through secondary competition and the current spend is \$6,508, 655. DoIT has determined it is in the best interest of the state to exercise option period 1 for two years. Approximately \$6,501,419.18 was spent on the previous contract.
