Ladies/Gentlemen:

This Amendment is being issued to change, add or delete certain information contained in the above named RFP. Specific parts of the RFP have been amended and the RFP changes are detailed below. The changes are marked with text underlined if it is new and crossed through if it has been deleted. This marking will help you more easily identify what has changed.

1. Revise, KEY INFORMATION SUMMARY SHEET (page 3), in the **Closing Date and Time** row, change Change ~~October 8~~, 2008 to November 6, 2008
2. Revise, Section 1.9 Proposals Due (Closing) Date (page 13)

In first paragraph, change “on ~~October 8~~, 2008 ” to “on November 6, 2008”.

In second paragraph, change “due date, ~~October 8~~, 2008” to “due date November 6, 2008”.

3. Attachment F, Section B) Attachment F2; Site Development, next to last sentence: Change:

The individual calculations for each row are: Col C x ~~Col E~~ = ~~Col D~~. Then, the individual ~~Column D~~ totals are summed to arrive at a grand total.

to:

The individual calculations for each row are: Col C x Col D = Col E. Then, the individual Column E totals are summed to arrive at a grand total.

4. Section 1.18 (page 15), add the following new paragraph between paragraphs #3 and #4 so that the last three paragraphs in Section 1.18 read:

Submission of uncertified MBEs or MBEs certified by a jurisdiction other than MDOT will result in a determination that the proposal is not susceptible of being selected for award. This includes MBEs which may have filed for MDOT certification but which have not obtained certification as of the bid or proposal due date. It

also includes MBEs whose certifications have expired and have not been renewed before the due date of a bid or proposal. In order to qualify, the submitted MBE must be MDOT-certified on or before the due date of the bid or proposal. The best means for an Offeror to check the status of a proposed MBE is to do a search of the company name field in the MDOT MBE/DBE Directory found here: <http://mbe.mdot.state.md.us/cgi-bin/mbedir/mbedirectory>

5. Section 1.18 (page 15), change the last paragraph to read:

A current directory of MBEs is available through the Maryland State Department of Transportation, Office of Minority Business Enterprise, 7201 Corporate Center Drive, P.O. Box 548, Hanover, Maryland 21076. The phone number is 410-865-1269. ~~The directory is also available at <http://www.e-mdot.com/>. Select the MBE Program label. The most current and up to date information on MBEs is available via the web site.~~
