


MSS0101 -Promotion Not From Recruiting




MSS0102 - Demotion Not From Recruiting




MSS0103 - Salary Adjustment

(Action = Salary Adjustment + Reason = 1) Advanced Step 2) Misc. Adjustment)

Assumption

-> Conversations have occurred at a minimum between the Supervisor/Mgr and the 2nd Level Manager that a Salary Adjustment action is appropriate. This process is the formality of entering the agreed upon action into the system.




MSS0104 - Process a Data Change – Change % Employed

(Action = Miscellaneous Adjustment + Reason = Change % Employed)


Assumptions

- > Conversations have occurred at a minimum between the Supervisor/Mgr and the 2nd Level Manager that a Change % Employed is appropriate.
- > The employee has been counseled on the impact this change may have on their salary, health benefits and leave accruals.




MSS0105 - Termination – Deceased

MSS0106 - Termination – New Hire – No Show or Declined Offer After Acceptance


(Action = Termination + Reason = 1) New Hire – No Show 2) New Hire – Declined Offer After Acceptance)



MSS0107 - Termination – Resigned for Military Service


(Action = Termination + Reason = Resigned for Military Service)

Assumptions
 -> Conversations have occurred to discuss the employee situation and a determination has been made that the employee is unable to return from their leave of absence and must terminate their state employment.
 -> This process is the formality of entering the agreed upon action into the system.




MSS0108 - Termination – Resigned State Service


(Action = Termination + Reason = Resigned State Service)




MSS0109 - Termination – Laid Off From Allocated Position



MSS0110 - Termination – Retired




MSS0111 - Termination – PIN Abolished




MSS0112 - Termination – End of Temporary Employment

(Action = Termination + Reason = End of Temporary Employment)




MSS0113 – Termination – Leave Without Pay


(Action = Termination + Reason = 1) Leave Without Pay – Medical 2) Leave Without Pay – Military 3) Leave Without Pay - Personal)




MSS0501 – Initiate Contractual Job Requisition and Position Number




MSS0502 – Initiate Contractual Job Requisition (Existing Position Number)
