- -The MAT program has received 148 new applications this quarter, an increase from 122 last quarter.
- -MAT program has distributed 270 pieces of equipment this quarter, an increase of 133 last quarter.
- -CF program has provided 137 services, an increase from 107 last quarter. For FY23 the CF program is at 304, this time FY22 it was 60. CF currently has 11 DeafBlind users.
