Charm Smith Receives 2015 Maryland Deaf Community Leader Award

Charm Smith of Ellicott City is the 2015 recipient of Hamilton Relay's Maryland Deaf Community Leader Award. Charm is the immediate past president of the Maryland Association of the Deaf (MDAD) and is described by her peers as a great problem solver and a tireless advocate.

Charm spends countless hours every week advocating for a variety of special interests that impact Maryland residents. She has been actively involved with Deaf and hard of hearing issues in government, and has been instrumental in helping to pass two state bills benefiting individuals who are Deaf. She supported the bill that established Early Hearing Detection and Intervention (EHDI) for babies born in Maryland. Another bill advocates for the establishment of the Deaf Cultural Digital Library (DCDL).

A supporter of many Maryland organizations, Charm is an active member on several advisory boards and councils. She serves on the Maryland Advisory Council of the Deaf and Hard of Hearing, advising the Governor's Office of the Deaf and Hard of Hearing. Charm also serves on the Governor's Advisory Board for Telecommunications Relay (GABTR).

Our team is hard at work on an initiative to make tablets available through the Maryland Accessible Telecommunications (MAT) program. The program will benefit qualified Maryland residents who are Deaf, hard of hearing, DeafBlind, low vision, or who have limited speech, mobility, or cognitive abilities.

Based on financial need, individuals will soon be able to receive free of charge tablets that will provide access to Maryland Relay's services in a convenient, portable device. Each tablet will come pre-loaded with apps to support better communication.
