# **Proposed New Interop User**

# Bedford County, PA – Represented by Brittany McConnell

Bedford currently has ~200 subscriber radios and mutual aid agreements with Allegany, Garrett, and Washington Counties. They plan to use MD FiRST in TDMA radios only. The initial use will be for Hyndman Volunteer Fire Department with approximately 25 radios. Bedford intends to communicate with mutual aid partners in Allegany County, the City of Cumberland, LaVale VFC, Corriganville VFC, MT Savage VFC, Ellerslie VFC, and others. Expected capacity impact: Minimal due to Interop only usage.

Proposed Motion: System Managers Committee suggests approval of Bedford County, PA application to become a Communications Interoperability User on Maryland FiRST.

## **SOP 0.13 Subscriber Decommissioning Procedures and Upcoming SOPs**

Brandon presented SOP 0.13 for the Subscriber Decommissioning Procedures. The committee would like more time to review SOP 0.13 before presenting it to the RCB for approval. Suggestion made to include language for destruction of radios that can not be cleared using normal means. Upcoming SOPs for review and committee approval will be Commercial Aviation/Air-to-Ground Conventional System and updating SOP 5 MD FiRST User Type/Application Process.

## **Open Discussion/Good of the Order**

Worcester County has transitioned to new frequencies, reducing the interferences being experienced.

Harford County will make a public announcement about their encryption mid-September. Will switch law enforcement to encrypted communications.

BWI conducted an active shooter training event. DoIT/MD FIRST participated with other local, state, and Federal agencies. MD FiRST was used for communication during this training event. It was run/hosted by. Customs and Border Control. It was suggested that future events at BWI include MDTA.
