## **Open Discussion/Good of the Order**

As a reminder, review your programs for commercial power at your sites: back-up generators, length of battery power, etc. MD FiRST/DoIT replaced generators and battery capacity at our core sites last year for improved power coverage.

MD FIRST/DoIT is now in the planning stages for FY24-25. Any new requests will go into the FY26 budget. We need budgetary proposals and requests as early as possible.

An ongoing challenge is getting MD radio users to switch over to the interoperable channels. This committee can help create policies, provide training, provide on-going communication with first responders to support using the interoperable channels. This committee could make recommendations to the Radio Control Board requesting they help inform counties and agency leaders to better utilize the statewide interoperability. **Examples:** At the Academy trainees must qualify for their weapon, they could have to qualify with their radio as well. DNR officers are not trained to understand how three Zones work or how to use the radio and interoperability. Howard county fire has written in their SOP to use MD TAC channels when in Patapsco area.

#### **ACTION ITEMS:**

Harold Taylor (Howard County) volunteered to write a recommendation for this committee and the SWIC.

Nate Durman (DNR/MNRP) to set-up a meeting to review interoperable procedures with MIEMSS and MSP to write up a Talkgroup sharing agreement.
