### CONTRACT MODIFICATION

THIS FIFTH MODIFICATION is made as of this \_\_\_ day of \_\_\_\_\_, 2023, by and between Town Hall Streams, LLC., (the "Contractor"), and the State of Maryland, acting through the Department of Information Technology (the "Department").

**WHEREAS**, on February 28, 2018, the Department entered into a contract with the Contractor for Meeting Live Streaming and Hosting Services, Contract No. 060B7400059, (the "Contract") pursuant to the Request for Proposals for the Meeting Live Streaming and Hosting Services, Project No. 060B7400059 dated April 13, 2017, and all amendments thereto issued in writing by the State (the "RFP"); and

**WHEREAS**, on February 9, 2021, the Department and Contractor modified the Contract to extend the period of performance on March 26, 2021 ("Modification 1");

**WHEREAS**, the Department exercised the first of two 1-year renewal options of the Contract and, on April 21, 2021, modified the Contract to increase the NTE from \$1,125,000 to \$1,510,000, ("Option 1/Modification 2");

**WHEREAS**, on February 28, 2022, the Department and Contractor modified the Contract to extend the period of performance through April 30, 2022 ("Modification 3");

**WHEREAS**, the Department exercised the second and final 1-year renewal option of the Contract on April 27, 2022 ("Option 2");

**WHEREAS**, on January 11, 2023, the Department and Contractor modified the Contract to extend the period of performance through July 5, 2023 ("Modification 4");

**WHEREAS**, the Contract, unless extended, will expire in accordance with its terms on July 5, 2023; and

**WHEREAS**, to ensure continuity of services, the parties desire to extend the Contract while the Department of General Services conducts a new procurement for the services and awards a new contract.

**NOW THEREFORE, IN CONSIDERATION** of the promises and the covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the parties agree


as follows:

1. **Duration of Contract.** Section 3 of the Contract is modified to extend the period of performance through July 5, 2024, with no change to the Contract's not to exceed value.
2. **Defined Terms.** All capitalized terms used in this Fifth Modification shall have the same meaning as provided in the Contract.
3. **Consideration and Payment.** Pricing for Option Year 2 shall remain in effect for the services during this extension period.
4. **Scope of Fifth Modification.** This Fifth Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of this Fifth Modification, all of the terms of the Contract shall remain in full force and effect and shall apply to this Fifth Modification.
