THIS MODIFICATION No. 3 (the "Modification") is made this day of 2019, by and between AT&T Mobility National Accounts LLC (the "Contractor") and the State of Maryland, acting through the Department of Information Technology (the "Department"), to the above-referenced Participating Addendum under the Western States Contracting Alliance ("WSCA") Master Service Agreement for Services of Independent Contractor, Contract No. 1907 (the "Contract").

WHEREAS, Contractor and the Department entered into the Participating Addendum dated January 8, 2013;

WHEREAS, on or about August 26, 2014, the National Association of State Procurement Officials ("NASPO"), the successor organization to WSCA, amended the Master Contract with Contractor, thereby extending the term of the Master Contract from October 31, 2016 to June 30, 2019;

WHEREAS, the Department and the Contractor entered into Modification No. 1 on September 22, 2016 to extend the term of its Participating Addendum with Contractor to June 30, 2019;

WHEREAS, the Department and the Contractor entered into Modification No. 2 on January 8, 2018 to incorporate the ability to purchase Custom FirstNet Mobile Phone Plans for the term of the Agreement;

WHEREAS, on or about March 22, 2019, NASPO amended the Master Contract with Contractor, thereby extending the term of the Master Contract from June 30, 2019 to December 31, 2019;

WHEREAS, the Department seeks to extend the term of the Participating Addendum to August 31, 2019;

NOW THEREFORE, in consideration of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the adequacy and sufficiency of which are



duly acknowledged, the parties agree as follows:

- 1. Section 4 of the Participating Addendum is modified by extending the period of performance through August 31, 2019.
- 2. The individual executing this Modification No. 3 on behalf of Contractor warrants that s/he has full authority to execute this modification to bind company principals.
- 3. The value, if any, of this Modification No. 3 is \$0.00.

Except as expressly modified herein, all of the provisions of the Contract remain in full force and effect and are hereby ratified and confirmed.
