WHEREAS, Contractor entered into the Participating Addendum dated November 15, 2012, with the Department;

WHEREAS, on or about March 22, 2019, NASPO amended the Master Contract with Contractor, thereby extending the term of the Master Contract from June 30, 2019 to December 31, 2019;

WHEREAS, the Department and the State seek to extend the term of the Participating Addendum to August 31, 2019;

**NOW THEREFORE**, in consideration of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the adequacy and sufficiency of which are duly acknowledged, the parties agree as follows:

1. Section 4 of the Participating Addendum is modified by extending the period of performance through August 31, 2019.


