WHEREAS, the Department and the Contractor entered into the Participating Addendum on January 10, 2013;

WHEREAS, on or about June 16, 2014, the National Association of State Procurement Officials ("NASPO"), the successor organization to WSCA, amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from October 31, 2016 to June 30, 2019;

WHEREAS, the Department and the Contractor entered into Modification No. 1 on September 22, 2016 to extend the term of the Participating Addendum to June 30, 2019;

WHEREAS, on or about March 22, 2019, NASPO amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from June 30, 2019 to December 31, 2019;

WHEREAS, the Department and the Contractor entered into Modification No. 2 on June 28, 2019 to extend the term of the Participating Addendum to August 31, 2019;

WHEREAS, the Department and the Contractor entered into Modification No. 3 on August 19, 2019 to extend the term of the Participating Addendum to December 31, 2019;

WHEREAS, on or about August 5, 2019, NASPO amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from December 31, 2019 to December 31, 2020 (see Exhibit A attached hereto and incorporated herein); and,

WHEREAS, the Department and the State seek to extend the term of the Participating Addendum to December 31, 2020;

NOW THEREFORE, in consideration of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the adequacy and sufficiency of which are duly acknowledged, the parties agree as follows:

- 1. That Section 4 of the Participating Addendum is deleted in full and replaced with the following:
 - 4. Effective Date and Time for Performance: This Participating Addendum shall be effective upon approval by the Maryland Board of Public Works until December 31, 2020, unless sooner terminated as provided herein.
- 2. That the individual executing this Modification No. 4 on behalf of the Contractor warrants that s/he has full authority to execute this Modification to bind company principals.
- 3. That the value, if any, of this Modification No. 4 is \$0.00.
- 4. That, except as expressly modified herein, all of the provisions of the Participating Addendum remain in full force and effect and are hereby ratified and confirmed.
