THIS MODIFICATION No. 1 (the "Modification") is made this 22nd day of September, 2016, by and between T-Mobile USA, Inc. (the "Contractor") and the State of Maryland, acting through the Department of Information Technology ("the Department"), to provide services and equipment pursuant to the terms and conditions of the Participating Addendum under the Western States Contracting Alliance ("WSCA") Master Service Agreement for Services of Independent Contractor, Contract No. 1907 (the "Contract").

WHEREAS, Contractor entered into the Participating Addendum dated November 15, 2012, with the Department;

WHEREAS, the term of the Participating Addendum will end on October 31, 2016;

WHEREAS, on or about June 17, 2015, the National Association of State Procurement Officials ("NASPO"), the successor organization to WSCA, amended the Master Contract with Contractor, thereby extending the term of the Master Contract from October 31, 2016 to June 30, 2019;

WHEREAS, the Department and the State seek to extend the term of the Participating Addendum to June 30, 2019;

AND FURTHER, WHEREAS, the Department seeks to modify its Primary Contact identified in the Participating Addendum;

NOW THEREFORE, in consideration of the Recitals hereby made a substantive part of, and the promises and covenants herein contained, the adequacy and sufficiency of which are duly acknowledged by the parties, the following Participating Addendum terms and conditions are modified and the parties agree as follows:

1. Section 4 of the Participating Addendum is removed in its entirety and replaced with the following:

4. Effective Date and Time for Performance: This Participating Addendum shall be effective upon approval by the Maryland Board of Public Works until June 30, 2019, unless sooner terminated by either party as provided herein.
