The DoIT Intake process serves as a "no wrong door" process through which agencies can initiate conversations with the DoIT team. The Intake process provides a holistic view of IT needs across all organizations, which aids DoIT in identifying commonalities that, if pursued, could mitigate risk, reduce redundant solutions, and decrease costs statewide. ## **Contract Updates**

### Agile Team Resources

The Agile Team Resources contract provides a comprehensive procurement solution to support the need for agile project delivery services. In February 2022, the contract was awarded to ten (10) CATS+ vendors that can provide services, through a secondary level of competition via the Work Order process, in the following three (3) categories:

- Category 1 Program/Project Management
- Category 2 Agile Consulting Services
- Category 3 System Development and Implementation

#### **DPMO**

The Delivery Program Management Office (DPMO) master contract allows agencies to acquire Information Technology (IT) project and program management services. Six (6) agencies have leveraged the DPMO contract since it was awarded in September 2021. Agencies should allow sufficient time to review proposals, interview candidates, and work through normal procurement processes (i.e., BAFOs, BPW approval, etc.), which takes approximately 3-4 months.

# Amazon Web Services (AWS)

The current AWS contract ends in May 2022. Over the next several week's DoIT is working to award the new contract and complete any transition activities, including billing reconciliation. #### Video Conferencing Survey

DoIT sent a survey to all agencies inquiring about their video conferencing equipment needs in conference rooms late last year. Based on the feedback we received and funding from DBM, DoIT has moved forward with finalizing the procurement. Once the acquisition is completed, the equipment will arrive in approximately 45-60 days. DoIT will notify agencies receiving video conferencing equipment separately. As a reminder, agencies are responsible for installation and setup of the equipment.

## SharePoint 2019 Upgrade - Completed

DoIT is proud to announce that all DoIT managed SharePoint websites have been successfully migrated to SharePoint 2019. Many thanks to the agencies involved for their partnership and support in the successful completion of this project.

# Security Awareness Training - Reminder

Monthly security awareness training, as required under SF&P 3A-314, is available to subscribing agency employees. Agency assigned Security Awareness Training Managers are responsible for requesting additions and deletions from the training service as personnel changes occur. # Wireless Local Area Network (WLAN)

Wireless Local Area Network (WLAN) service provides mobile internet use within an agency building to authorized State of Maryland government employees and guests. This service wirelessly integrates and extends the agency's local area network (LAN).

### Email and Collaboration Services

Statewide email and collaboration services are provided via Google Workspace Enterprise-Plus (formerly G Suite). The platform includes collaboration tools like Gmail, Calendar, Meet, Chat, Drive, Docs, and more.

### Managed Vulnerability Service

DoIT's managed vulnerability solution provides agencies with the apparatus to gain comprehensive visibility into the security posture of their resources. This insight helps to identify things like missing patches and software misconfigurations that leave systems open to attackers.

### Digital States Survey Responses Needed

The Center for Digital Government is conducting its biannual <u>Digital States Survey</u> and Maryland's response is due very soon. ## Google Vault (VFE) Changes

Google VFE (Vault Former Employee) is the tool used to "archive" GMail accounts once they are disabled in the event that information is needed in the future. For the past several years, VFE was included with the state's GMail service at no additional charge. In January agencies were notified that VFE will be converted to Archived Users (AU) licenses and will no longer be free. In the upcoming weeks, DoIT will begin purging the accounts that agency IT contacts confirmed were no longer needed. Any account data agencies wish to retain will be exported and transferred to the agency to maintain.
